## Parental Consent Form for St Edmund's and St Joseph's Catholic Primary Schools

It is a legal requirement that we have the permission of pupil's parents/guardians when taking pupils out of school, displaying photographs or using biometric data.

Pupils are often taken out of school on local visits such as to the market or Moyes Hall/Thomas Gainsborough Museum so rather than send you a letter on each occasion we ask you to give permission below.

Occasionally, we may take photographs of the children at our school. We use these images as part of our school displays and sometimes in other printed publications. We may also use them on our school website, Facebook page and Twitter account. If we use photographs of individual pupils, we will not use the name of that child in the accompanying text or photo caption. If a child has won an award and the parent would like the name of their child to accompany their picture we will obtain permission from the parent before using the image.

Learning Journeys are used to celebrate your child's progress throughout school. These are sent home at the end of Year 6. Photographs of individuals, groups or classes of children may appear in these records.

From time to time, our school may be visited by the media who will take photographs or film footage of a high profile event. Children may appear in these images, which will sometimes be published in local or national newspapers, or on approved websites.

We currently use a biometric facility in the library for children to borrow books. The information used is already held by the school eg name, date of birth, gender and class. The recognition system will not be used or shared with anyone outside the school. The system will only be used when children take out a book from the library. If you choose not to have your child registered on the biometric system then we can manually issue them a book.
